Responsibilities include:

- Developing an understanding of the student conduct process
- Participating in training sessions facilitated by the Office of Student Conduct and Office of Student Legal Services
- Participating in Student Conduct Reviews per the procedures set forth in the Student Conduct Code
- Upon concluding a Student Conduct Review, determining whether the Respondent student has violated this Code based on a Preponderance of the Evidence
- Maintaining confidentiality related to all aspects of the Student Conduct Review process
- Serving as a resource to the Warren College Student Council Community Conduct Outreach Board and assisting with their educational outreach programs, which aim to educate Warren College students about student conduct, academic integrity, the principles of community, and community standards and expectations

- Must be a currently enrolled undergraduate student, registered in Warren College
- Preference given to individuals in good academic and judicial standing
- Ability to fulfill all stated responsibilities of the position indicated above
- Ability to serve in this position for a minimum of one academic year with the possibility of reappointment
