  - a. Library Hours
    - i. System-wide budget cuts within UCs
    - ii. Cut 24 hours at Geisel even during finals and midterms
    - iii. Increasing budget in the next couple years but as of now there is no discussion amongst UCs on reversing this
    - iv. Skyler: there is talks about college councils doing something
      - 1. Maybe just a resolution or showing that we don't approve of the fact that our chancellor is making so much money but library hours were cut due to budget cuts
      - 2. Even first years were upset, even though they haven't experienced it
    - v. Nam: Budget cuts were in the billions. Library cut won't have intended impact
    - vi. Jin: first-year transfer, upset because had opportunity to study over summer here and has been impacted by this; it impacts everyone as a hold
    - vii. Ghazal: understand that this is a big budget; library is one of the main resources you have on campus to study late. It's safe; you used to be able to go to it whenever
